



We supported Anymile (a subsidiary of the Mitsubishi Electric Innovation Center in the US) in applying for SMART Grants for the use of drones in wildland fire logistics and helped them build a strong consortium with Volatus, the UAS Center at the San Bernardino International Airport (SBD) and Anzen Unmanned.



We supported Enerjisa with their US market research strategy, identifying grant opportunities, and conducting policy research. Our comprehensive approach helped them navigate the complexities of the US market and optimize their growth potential.

We also assisted their spin off: Coral Charge.



We assisted <u>Superpedestrian</u> in entering the Turkish market, securing operations permits for nearly 5,000 e-scooters from the top three cities in Turkey, including Istanbul. This deployment made the company the **fourth-largest** in the country.

Our Traction (2)

We helped <u>Reef Technology</u> secure three grants from the US government, specifically from CalEVIP and BAAQMD in California, and EV Make Ready in New York. These grants, totaling \$434,000, funded the installation of 34 Level 2 EV charging stations where the total expense can rise to around \$10,000 per station¹.

We guided Zed Motors through their USADF Off-Grid Energy Challenge Grant application, securing \$250,000 in funding to support off-grid projects. This grant will enable the expansion of their electric motorcycles and solar-powered battery-swapping stations throughout the Benin Republic.

We helped <u>AmpUp</u> win an RFP from Green Mountain Power in Vermont and also drafted their grant application with Forth Mobility. Please find the details of the project <u>here</u>.



We facilitated the launch of the first 1,000 scooters for GBike, Asia's largest micromobility operator, in Los Angeles, joining 6 main operators with 6,000 each.² This marked the company's initial expansion into the US market.

GCOO

We supported Kite Mobility's successful grant application to the Ontario Centre of Innovation (OCI), enabling their collaboration with Indigo on a \$1.1M project. As a result, OCI contributed \$381,000 in funding.



With our strategic guidance and support, Blok-Z—an Alchemist Accelerator startup—has attracted a \$500,000 investment from Simya VC. This partnership positions Blok-Z to streamline access to hourly carbon-free energy.


